Subject- School affiliated letter for the purpose of Article 18 of the Free and Compulsory Education of Children Act, 2009, under the Sub-Rule (4) of Rule 15 of the Children's Free and Compulsory Education Rules, 2010.

Dear Sir/Madam,

In the reference to the letter of inquiry / inquiry to the school with regard to your request, I send the recognition for the period of March 31, 2020, from Global Public School, Ranga Bhangala Block Mukerian-II, from Nursery to 8th class.

The above accreditation is based on the following criteria:-

- 1 Accreditation of approved accreditation is not valid and in any case this should not mean that it is mandatory for recognition from the eighth grade.
- 2 School will comply with the provisions of the Free and Compulsory Education Rights Act 2009 and Children's Free and Compulsory Education Rules, 2010.
- 3 The school will enroll 25% percent of the total number of students in the first class and the children around the non-deserving group and the free and compulsory primary education till completion of this.
- 4 According to the provisions of sub-section (2) of section 12 of the Act, the expenditure for children given to the school in paragraph 3 will be reimbursed. To fulfill this, the school has to have a separate bank account.
- 5 The institution / school will not accept a capitation fee and will not adopt any method of choosing children or their parents or surfers.
- 6 Schools will not refuse admission to a child because there is no proof of birth and the school will follow the provisions of Section 15 of the Act to ensure that
  1. No enrolled child will be taken back to the college or taken out at school unless the primary schooling is completed in his school.
  2. No child will be subjected to physical abuse or mental harassment.
  3. No child will be required to pass any board exams until the elementary education begins.
  4. Every child who has received basic education will be given a certificate of return as per rule 25.
  5. Integrated students of special needs according to the provisions of the Act.
  6. For teachers, it is necessary that they meet the minimum educational qualifications under section 23(1), but the condition is that existing teachers who receive minimum educational qualifications while applying for this Act.
  7. Section 24 (1) of the Teacher's Act fulfills the eligibilty obligations.
  - 8 .Teachers will not keep themselves busy in private tuition.
- 7 Schools will follow the syllabus determined by the appropriate authority based on the subjects of instruction.
- 8 In this school, no unauthorized class will be run in or outside the school premises.
- 9 The school building or other frame or field will only be used for education and qualification development.
- 10 The school is run by the Society registered under the Societies Registration Act 1860 (21 of 1860) or by the Tribunals created under any applicable law from time to time.
- 11 School is not being run for the benefit of any private group or group of individuals or any other person.
- 12 Records should be audited by a certified Chartered Accountant and the statement of accounts will be prepared as per rules. A copy of each audit will be sent to the District Education Officer (A.S) every year.
- 13 Your registered school code No-RTE-094 should be noted and registered with this office while registering it.
- 14 The school will submit information requested from time to time by the District Education Officer and follow the instructions made by the appropriate authority or District Education Officer who will be issued to fulfill the conditions for accreditation or to overcome the shortcomings in schools.
- 15 Ensuring renewal of registration of the institution if necessary.
- 16 The school will comply with the terms and conditions set out in Section 19 of the Act.
